

# An Introduction to Washington Water Law

Washington state adopted its first water code in 1917 to create a legal framework for the allocation of water for human consumptive needs. In recent decades continuing population and economic growth, and the need to ensure a sustainable resource have created unprecedented legal, economic, and political pressures on our state's water supplies. Climate change, the recognition of groundwater and surface water as a single resource, and the vital role groundwater plays in creating base flows for our streams and rivers are just some of the issues that underscores our need to create sound management practices that balance the needs of people and the environment.

This presentation will center around the basic framework of the state's groundwater code, how water is allocated, the nature of water rights, and the development of management tools for the preservation of water supplies that support aquatic and other wildlife habitat, water quality, and recreational uses. Examples of how scientific studies have shaped policy on future water allocation in light of today's challenges will also be presented.




## **Bio: John Rose**




