



# State Lands Post-Wildfire Salvage Logging and Landslide Mitigation Strategies

Wildfires are becoming increasingly common, including on Washington state trust lands. These wildfires leave landscapes more prone to sediment erosion, landsliding, and flooding. Forest practices, such as logging, can exacerbate these risks.

Washington Forest Practices' rules are some of the most rigorous in the world and include specific regulation of potentially unstable slopes and landforms. These rules prohibit sediment delivery to public resources or in ways that threaten public safety. The rules still apply to both live-tree harvests and salvage logging of dead trees in post-wildfire environments. However, studies show that salvage logging can increase risk of sediment delivery in a post-wildfire landscape, so additional mitigation measures are warranted. In this talk, we will review post-wildfire risks, DNR salvage logging, and various mitigation measures. This will include a case study of a salvage sale in the Schneider Springs wildfire (2021) area. I will also introduce a new field and drone survey project we are initiating to assess the effectiveness of these salvage logging mitigation measures.

You know what they say, April showers bring May flowers. And boy, that is has! Personally, my favorite it are cherry blossoms... but isn't that most peoples?


